Reprogramación de fondos del año anterior para viviendas
asequibles, desarrollo económico e infraestructura públicas

The Department of Housing and Community Development of Prince George's County, Maryland will accept applications for the Community Development Block Grant (CDBG) Program Year 47R (Reprogramming), covering Fiscal Year 2022-23 for shovel-ready Affordable Housing, Economic Development and Public Facility-Infrastructure Projects. Applications will be available online on Thursday, April 28, 2022. The application submission deadline is Thursday, May 19, 2022 at 5:00 p.m.

CDBG funds promote viable communities by providing decent housing, suitable living environments, and expanding economic opportunities to low and moderate-income persons. The County anticipates allocating approximately \$800,000 up to \$1 million of Reprogramming funds. Reprogramming funds are remaining balances from completed CDBG activities, Program Income, and uncommitted funds available from Program Years 42 thru 46. Applications will be accepted, and consideration will be given to shovel-ready projects for the following funding categories: Affordable Housing, Economic Development, and Public Facilities and Infrastructure. Additionally, Applicants with outstanding prior years funding, including Program Year 45 and prior, may not be eligible for funding.

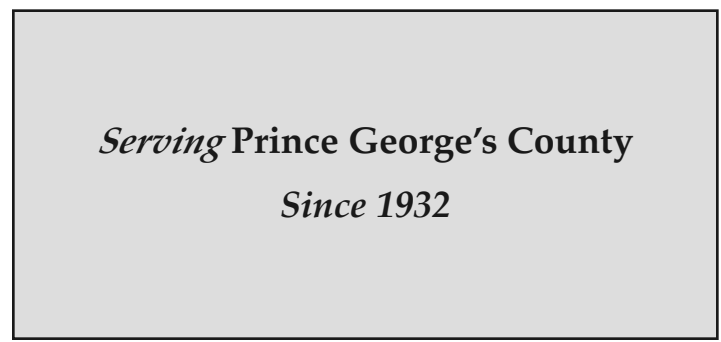
